



## 2018/19 Aboriginal Post-Secondary Education Bursary Fund

**\*Deadline for submissions is Friday November 7<sup>th</sup>, 2018 by noon. Late applications will not be accepted \***

The intent of the bursary fund is to support applicants who clearly demonstrate the need for financial assistance while enrolled in one of Kenjgewin Teg's current post and secondary programs.

All applications are assessed in accordance with established criteria. Bursary funds do not have to be repaid.

### Application Guidelines

#### WHO CAN APPLY?

You are eligible to apply for the **2018/19 Aboriginal Kenjgewin Teg Education Bursary Fund** if you meet ALL the following criteria:

- A Canadian resident, Aboriginal individual who is either First Nation status, non-status, Inuit, or Métis;
- An Active Student enrolled in a part-time or full-time program at the post and secondary level in a program of study that is a minimum of one academic year - at an accredited university or college *in partnership with Kenjgewin Teg* and pursuing a certificate, diploma or degree.

#### Criteria:

- One letter of reference is required from an Instructor in current enrolled program.
- Proof of First Nation, Inuit or Métis ancestry.
- Social Insurance Number is required, to be submitted with application
- Letter or Technology piece (including, but not limited to; Power Point, Prezi, iMovie, etc.) or an Art Piece (for example painting, carving etc.), this piece will represent your passion and journey through Education:
  - a. State reason for choosing current field of study (in letter) if you choose a technology piece, this will be an oral presentation, to the bursary committee stating below;
  - b. Explain why you are passionate about current field of study and committed to completing current program;



- c. Identify your goals for your future career and employment;
- d. **Demonstrate financial need – complete attached financial form.** *All financial information that you submit is kept **STRICTLY CONFIDENTIAL**;*
- d. Include any special circumstances that you think the review committee should give consideration to in reviewing your application.

*Note: Submitting an application does not guarantee that an applicant will receive funding. There is no set amount for bursaries – every applicant is assessed individually. The level of financial assistance varies according to the assessed financial need of applicants, the number of applicants, and the availability of funds for allocation.*
